



A Not-So-Silent Auction



- Select a few great auction items.
- Get member volunteers assign them to an item and design a Zoom branch show.
- Focus on creative presentations.
- Funny & silly works professionals are not required!



A Not-So-Silent Auction

Each presenter showcases their item: display it, sell it! Give its value and bid information.

- The presenters can be in costume, silly disguises, singing do anything for an appropriate laugh.
- Rehearse before the event!
- Tell participants how to bid!





A Not-So-Silent Auction Using Zoom

- Select items that are visible and of interest to your virtual audience.
- Review a typical bid sheet and think through the pros/cons of Zoom bidding.



- Use the "Chat Room" and time the bids for the duration of the meeting?
- Use email to bid?
 - Give a deadline (a few days? a week?)
 - Send frequent updates on the bidding wars. Keep the momentum!
- Got other ideas? Think it through.

Have an Untea Party







Have an Untea Party

- Mail a teabag and a donation form to all members. Perhaps include a return envelope.




Build a Tech Trek Girl





Build a Tech Trek Girl

- To fund a campership, members buy body parts: an arm or a leg for \$100 each, the trunk or the head for \$300 each.
- Special Interest Groups or local businesses could each buy an entire girl to send to camp.





Flamingo Flocking for Funds





What is Flamingo Flocking?


The branch purchases a **"Flock of Flamingos."**


- Anyone wishing to surprise a friend/recipient will be charged a fee for placing the flock on the recipient's lawn overnight.
- Honor someone's special day be it a birthday, anniversary, or graduation by "flocking them." What a fun way to share their joy, and even show their neighbors they have how special they are!



Some Things to Think About

- Confirm that this is allowable by contacting the police department prior to placement.
- Consider charging separately for placement and removal of your "flock."
- Place a sign stating "You Have been Flocked" by ____" and that AAUW programs will receive the donation.





Share Your Savings

These days we are meeting via Zoom and holding virtual events.

How about organizing a fundraiser around the money being saved on things such as gas, entertainment and dining out?









A Virtual Trip

- Travelers donate by buying airline tickets to go on a virtual trip.
- Ticket holders depart weekly on Zoom to exotic destinations.
 - "Tour guides" present information on the destination, its history, culture, touristy sites, fun facts, etc.
 - Show photos of the hotel.
 - Play music from that country.
 - Show inspirational videos of scenery, people, etc.
 - Demo a cooking class.
 - Ask your travelers to open their suitcase; show two favorite things to pack.
 - Consider upcharges for add-ons:
 - Snacks on the flight
 - Hotel upgrades to suites

One member is the "travel agent" to handle the donations and recordkeeping.





Amazon Smile (Maybe)



You can only smile if your branch (or an entity of your branch) is a 501(c)3.

- Register your branch as a charity with Amazon Smile.
- Members sign up for Amazon Smile and pick your branch for their donations.
- Members shop as usual on the Amazon Smile website (has the SAME stuff).
- Amazon donates .5% of the price of eligible purchases to YOUR BRANCH.
- Members shop with abandon during COVID, tell all their friends and family, and you make millions.



Trick or Treat



- Definitely a one-day fundraising event!
- Board members dress in costume and visit members' homes to trick or treat.
- They can ask the board member for a "trick" first, then make a donation.
 - Sing a song.
 - Recite the alphabet backwards.
 - Do the Hokey Pokey.
 - Recite a poem.

Ask for permission first with an opt-in survey of members. Include an opportunity to send a check instead.



A Grown-Up Spelling Bee or Trivia Contest

- Branch members, friends, outside organizations form teams and pay a fee to play.
- Teams compete to spell words or answer trivia questions.
- If someone misses the answer, they can buy back in with a donation to keep their team alive.
- This is "Zoomable." Consider break-out rooms.
- Prizes could be:
 - Nothing but glory



Members deliver homemade meals to

winners.




A Non-Event Event

People can donate for NOT doing something, such as a non-marathon.

Members donate to NOT participate.

- Donations are tiered: more money to NOT run more miles.
- Consider add-on donations:
 - NOT buying running shoes.
 - NOT buying Yeti water bottles.
 - NOT getting up at 6:00 am.
 - NOT being seen in exercise clothes.



This is a relief to many who really just want to write a check.




Reaching Community Pockets

Members continue their generosity, but we wanted to expand the donor pool for you.



- Consider sources of grant funding, including community foundations and other nonprofits that must disburse their funds.
 - Look for community-based foundations that raise funds through their own non-profit businesses like a thrift shop.
 - Other sources might be community organizations that host events such as golf tournaments to raise funds for non-profit organizations.
- Check Guidestar (guidestar.org) for information on grant makers for nonprofits.



Open Branch Events to the Public

Consider how to engage non-members in many of the types of events and non-events we have outlined for you.

Many of the creative ideas presented in this webinar could be open to the public such as the 'Flamingo Flocking", Not-So-Silent Auction and Build a Tech Trek Girl.

Promote widely through social media and other channels your branch uses.



Fundraising Guidelines

- Fundraising MUST be for AAUW National or branch programs.
 - No raising funds for other charities
- Donor Bill of Rights: use of gift in line with donor expectations

Fiscal Integrity

- Comply with IRS regulations.
- Use good accounting practices for funds raised, expenses, etc.
- Maintain transparency, e.g. in selection of scholarship winners.
- Include what the funds will be used for on event signs and flyers and promotional materials.





Tax Deductible or Not?

- Donations are tax deductible if they are made to a 501(c)(3).
 - AAUW Funds
 - AAUW CA SPF (Special Projects Fund)
 - College or foundation for scholarships
 - To branch if 501(c)(3)



- How to make a tax deductible donation:
 - Have donor make out check directly to 501(c)(3) entity.
 - Tax deductions for events with ticket sales are more difficult.
- Notes to donors (required for \$250 or more)

Be Aware of IRS and California State Rules

- Sales tax must be collected if selling items.
 - Get Seller's Permit from California Department of Tax and Fee Administration (CDTFA).
 - File sales tax paperwork and pay.
- Careful with raffles
 - Expense must be 10% or less.
 - 50-50 raffles are illegal in California.
 - Paperwork must be filed.
- Events with ticket sales
 - Determine "fair value" of goods and services provided.
 - Donation = Ticket price fair value.



Auctions

Miscellaneous Issues

- Should an IBC hold a fundraising event?
 - IBCs are not affiliates of AAUW.
 - It's better to let one of the branches of the IBC do fundraising for it.
- Collaborating with other like-minded organizations is allowed.
