AAUW Dues, Fees, and Tax Deductibility

Effective July 2022

AAUW California members pay a bundled payment for three organizational segments

- 1. AAUW National dues
- 2. State dues
- 3. Branch dues, if a branch member, are set by the individual branches, are not uniform, and are in addition to AAUW National and AAUW California Dues.

Dues are typically paid in a single payment, collected by the branch or paid online by the member via the Community Hub.

Tax deductibility

AAUW national membership dues are \$72 of which \$69 is tax deductible as a charitable contribution.

AAUW national paid life membership dues are \$1,340 and are fully tax deductible.

C/U membership dues are \$175 and are fully tax deductible.

Student membership dues are \$18.81, of which \$16.81 is tax deductible. (This amount never changes.) **Shape the Future membership** dues are \$33.50 of which \$32.00 is tax deductible.
