What and why is an online branch? Everyone is familiar with branches that you can attend in person. The beauty of an online environment is the absence of geographical barriers in defining membership. The California Online Branch was established in 2001 as an experiment in creating a "virtual" community. The branch currently has members residing in eight states, comprising 32 primary members and 73 dual members. There are quarterly program meetings, a monthly newsletter, several interest groups, a board of directors, and a monthly no-agenda gathering. Why do people join? There are probably as many reasons as the 105 members. Some reasons include no nearby in-person branch, the virtual environment works well, the various offerings are interesting, it is only an additional \$15 per year to become a dual member and meet new like-minded people, people move away from their primary branch, they don't want to drop their membership, but they want to remain active in AAUW and **many more reasons**. AAUW California Election in progress

Our state election began April 26th and runs through May 16th. An email was sent to all members at about 8 am on April 26th. Those without email received a paper ballot, which must be returned by May 16th to be counted. You are asked to vote to approve our Biennium Public Policy Priorities and a dues increase and to vote for two candidates for the State Board. Please vote and have a say in your organization.

Consider applying for a State Committee

Applications are now available and will be accepted until May 31st. This is a wonderful way to bring your skills and passion for all things AAUW to the state level to aid all branches. Committees meet monthly on Zoom and have varying responsibilities. All committees accept applications for general members; some also have specific roles for which you may apply. Dues Increase Questions

There have been questions regarding the dues increase, should it pass during our election. It will be in effect for the 2025-2026 AAUW year, starting July 1st. Since we are currently beginning renewals for the next year now, any renewals that are processed before the end of the election, and the announcement of the results, will be subject to the current dues rate of \$20. Provided the dues increase passes, any renewals after that will be at the \$30 rate. Branch officers should submit renewals as they come in so that it won't be necessary to go back to members later for the increased amount. National stays strong on our values

Despite the rhetoric and attacks on higher education, AAUW remains strong as a tireless advocate for women in higher education. We do not receive any federal funds so the bans on Diversity, Equity and Inclusion programs and language do not apply. UPDATE FOR ALL BRANCHES SENDING STUDENTS TO NCCWSL

If your branch plans to send students to NCCWSL, we have some information for you.

 NASPA has arranged for a block of hotel rooms for students from the west coast who arrive on May 27th, the day before NCCWSL begins. The conference is May 28-30 with the opening session at 5 pm on May 28th. Click <u>HERE</u> for the cost and registration process. You can now reserve a room for your students on May 27th by clicking <u>HERE</u>.

NASPA has confirmed with the hotel that students under the age of 21 will be able to check in and that you can provide a credit card for incidentals ahead of time, if they are using an AAUW or institutional card instead of their own. Please work with the hotel directly if you would like to put a card on file for incidentals. On May 28th, students will need to check out of the hotel and check in at the Adele Stamp Student Union, between noon and 5 pm. The NASPA website has links to the campus map.

Is any branch sending an adult, either a C/U chair or an administrator from the campus? If so, please let us know at <u>cu@aauw-ca.org</u>.

- Please ask the students that you send to NCCWSL if you can share their name and email address with California AAUW. We plan to have a Zoom session with the students who attend NCCWSL to get their feedback and suggestions. Please send the names and email addresses of the students attending NCCWSL to <u>cu@aauw-ca.org</u>.
- While there is no formal tour of DC planned by NASPA this year, we will continue to request this. If students arrive in the evening on Tuesday, May 27th, and check into the hotel, they may take it easy the next day since the conference starts at 5 pm on Wednesday, May 28th. However, if they want a brief DC experience, here's one idea. Students either use ride-sharing services or transportation systems to travel to DC and take advantage of tour opportunities, such as the Hop-on Hop-off (Hop-On Hop-Off Washington D.C. Bus Tours [Top Attractions]). A one-day ticket is \$59. Or try the Big Bus tours Washington DC Hop on Hop off Bus Tours | Big Bus Tours, for \$75. Since time is limited, students would only be able to hop off at one or two sites. The logistics are complicated in that students will need to check out of the hotel and have the hotel store the luggage. There may be an option to drop luggage off at the NCCWSL site, located at the Adele Stamp Student Union. We will hear if that is possible in a couple of weeks. But the hotel is on campus, so either luggage storage location can work. However, remind students that there will be traffic on their return trip, and they should plan to get back by 3:30 pm to pick up luggage, walk to the middle of the campus, and check in at the conference site, Adele Stamp Student Union.

College/University Partner School Membership News

Donations to NCCWSL can be remitted to AAUW National just as any other donations, either via check with NCCWSL Scholarship (2504) in the memo line of the check or on a supporting document, such as the Contribution Report Form. If you'd like to make the donation online, Tremayne can facilitate that with an Express Payment Link. This allows you to donate on behalf of the branch to NCCWSL Scholarships since it's not one of the current funds available on the general donation page.

If a branch is interested in making an online payment, send an email to <u>connect@aauw.org</u> and be sure to put 'Express Payment Link' in the subject line. Then, please notify AAUW of the gift amount and the fund your branch wishes to support (in this case, NCCWSL Scholarships). AAUW will promptly send you a link for the donation, which you will use for payment. According to Tremayne, the links are generated on the same day. Please ensure that you include your contact information in case AAUW has any questions.

ONE YEAR ENDS, THE NEXT BEGINS

It's the end of the fiscal year – a time for membership renewals and welcoming new members, wrapping up the old year, and planning for the new year.

Your branch may be deeply involved in these activities and more. The <u>April 3rd Finance Peer Group</u> recording is posted on the AAUW California website, and the PowerPoint and other session documents should be posted shortly. Be sure to use these resources if you have questions about the HUB, year-end reports to support government filings in the fall, finding missing documents, branch structure, and more. All peer group sessions for the past two years are posted to <u>Peer Groups –</u> <u>Finance</u>.

Branch officers, especially those newly elected, may wonder about liability coverage. Our insurance policies include General Liability, D&O (Director and Officer) Liability, Fiduciary Liability, and more. If you are planning a fundraiser or other event and need a Certificate of Insurance for a vendor or sponsor, you can find the form to request one <u>HERE</u>, then select "Managing Branch Insurance," followed by "Branch Insurance, option #2."

The Insurance coverage period follows the AAUW California fiscal year and is renewed and funded by AAUW California to ensure uninterrupted protection for all branches. Branches are invoiced in the fall based on their membership count as of February 1st. We keep you covered year-round. The Finance Committee has invested considerable effort in supporting branch finance officers. We know it's critical to provide timely information so finance officers can meet all their very important job requirements. Be sure to let us know what you need to know that has not been addressed so far. As always, you can reach us at <u>cfo@aauw-ca.org</u>.

BE A TRANS ALLY

Trans Allyship Guide - Learn how to have conversations and be an ally

The AAUW of California Public Policy Trans Allyship guide has finally launched! Check it out by clicking <u>HERE</u>.

This guide is for anyone who wants to continue to ally with transgender and nonbinary people. It is meant to be a complement to existing guides, such as those produced by well-known gender equity and transgender and nonbinary support organizations such as The Trevor Project, PFLAG, GLAAD, HRC, and Amnesty International. While some of the existing guides already contain important information about inclusive language and terminology, **our guide is unique in that it specifically focuses on how to have everyday conversations about transgender and nonbinary social and policy issues**, offering sample responses to common questions that YOU, our members have encountered while engaging in allyship and advocacy work. **Please keep those questions coming, as this is a living document! We will update content regularly.**

AAUW California Mobilizes to Advance Priority Legislation

AAUW California advocates came out in full strength on April 8th and 9th to participate in Lobby Days 2025. A total of 197 people representing 66 branches, including our Public Policy Interns and other college students, turned out to advance our priority legislation. 84 people came to Sacramento on April 8th to meet in person with legislative offices; 104 people held virtual meetings via Zoom on April 9th, and nine people met in district offices. Because many offices prefer to keep their calendars open until the last minute, our committee worked furiously right up until the day of the event to schedule meetings. Meetings were requested with all 120 legislative offices, and 94 meetings were secured. **In other words, we met with 78% of all legislative offices - a record for AAUW California!**

Unsurprisingly, there were a few hiccups, but a vast majority of the meetings went off smoothly. While most meetings were with staff, ten meetings were held with legislators. Reports from the teams indicate that all of the meetings were courteous and cordial, including those with offices that did not agree with some of our positions. Many teams were received with enthusiasm and gratitude for AAUW's scholarships, activities, and programs such as Tech Trek. Some staffers expressed interest in joining AAUW, and one staffer generously shared information with our Public Policy Interns about a Fellowship program she participated in, which ultimately led to her current job. Overall, we successfully met with 94 offices to advance our key legislation and increased awareness about AAUW and all the things we do to advance gender equity.

We asked the legislative offices to support SB 771 and SB 418, and oppose AB 579. SB 771 (Stern) "Social Media Platforms Endangering Californians", sponsored by AAUW California, would hold social media platforms liable if their algorithms or AI aid or abet users to intimidate and threaten marginalized groups. SB 418 (Menjivar) "Ensure Equal Access to Care for All" would prohibit a health plan or a health insurance provider from denying coverage or denying benefits to a person based upon their race, color, national origin, age, disability, or sex - including sex characteristics such as intersex traits, pregnancy, and gender identity. AB 579 (Castillo) "Yaeli's Law", which we opposed, would prohibit parental denial of support for youth self-identity from being considered as child abuse and the basis for custody or removal decisions.

Our positions on SB 418 and AB 579 are protective of the rights of transgender people, meeting the challenges of the current moment. A number of the offices expressed support for our positions with empathy and personal stories about legislators' family members who are transgender.

Shortly after our Lobby Days event, we learned that AB 579 is dead. The bill was held in the Assembly Rules Committee and was not referred to a policy committee, effectively killing the bill. We quickly replaced AB 579 with AB 1098 (Fong) "Title IX and the California Sex Equity in Education Act" as our third "A" priority bill. AB 1098 would expand protections for pregnant graduate students and institute protections for pregnant undergraduate students, prohibiting postsecondary educational institutions from discriminating against a student based on their current, potential, or past pregnancy or pregnancy-related conditions.

We invite you to track the progress of our top three bills, and all of the bills on our Legislative Agenda, by viewing the <u>2025 Bill Tracking Report</u>. The report will continue to be updated as the bills move through the legislative process, so you can always check back to see the latest status.
