A change for both areas includes a new Public Policy Fund #4514. To quote the National Membership email sent 10/30/25: "This new fund fuels advocacy initiatives across key issues like pay equity, student debt, Title IX, and increased mobilization of our Action Network. "A branch donation to this Fund or Fund #4513 (Defend Higher Education) completes one of the three requirements needed for the Advancement star. Donations to the old Public Policy Fund #4337 will continue to count for this year only.

Also highlighted in the meeting was that one activity can count in more than one area. For example, for all of you who ran a public policy program this month to educate voters, that counted as one requirement for a Public Policy star and one of the four needed programs for the Programming star, a two-for-one deal!

Successful branches develop a checklist of the Five-Star criteria, one member keeps track, and the branch's progress is included in newsletters and meetings – share and succeed!

### GETTING THE COBWEBS OUT: GIVE YOUR BRANCH WEBSITE A SEASONAL SWEEP

If your branch has a website, regularly reviewing the website content is one of the most straightforward ways to protect credibility and keep viewers engaged. Over time, the relevance of the content changes: events pass, leadership changes, dates and statistics go stale, and links break. This process is important because even small inaccuracies can erode trust in the website and reduce its usefulness to members and potential members.

Start with a list or catalog of pages. Then review the content on each one, checking accuracy (facts, dates, names), timeliness (events, deadlines, program statuses), and relevance (is this still helpful?). Also, verify any links, as links to outside websites are prone to breaking over time.

In terms of frequency, ideally, review the key pages (such as the homepage, upcoming events, donate/join, contact us) more frequently, and review the other content annually. A best practice is to assign each important page an owner so that updates are not "everyone's job" (and therefore no one's job). One might even choose to track revisions and next review dates in a simple spreadsheet.

A modest, recurring review cycle can keep your website accurate and trustworthy, more of a dependable, up-to-date resource than a static brochure.

# 2025 LEGISLATIVE AGENDA - SOME BIG WINS AND TOUGH LOSSES Legislative Agenda

October 13th was the final day for Governor Newsom to sign the bills on his desk. Of the fourteen bills on AAUW California's Legislative Agenda which made it to his desk, the Governor signed 11 and vetoed 3, including two of our A priority bills - SB 771, sponsored by AAUW California, and SB 418. While it is disappointing that our A level support bills did not do better, we are celebrating the 11 B and C level support bills that were signed, alongside the resounding failure of three of the bills that we made it a priority to oppose. Three Steps to Take Action in November - Focus: Protect Voting Rights

**STEP 1: Self-Focused: Education** 

- Learn more about and follow the Supreme Court case *Louisiana v. Callais*. This case will address a Louisiana-based challenge to key aspects of Section 2 of the Voting Rights Act, which prohibits racial discrimination in voting. Should it be overturned, the consequences will be profound for the entire nation. AAUW CEO Gloria Blackwell has weighed in on this case (see remarks at 1:28:24).
- Learn more about the Safeguard American Voter Eligibility (SAVE) Act. The United States House of Representatives has passed the SAVE Act (HR 22), which would require every eligible voter to provide documentary proof of citizenship to register to vote. While this sounds potentially harmless, such measures have been shown to lead to voter suppression—and disproportionately impact women. AAUW formally opposes the SAVE Act.
- Learn more about how Voting Rights have recently been challenged in California, including through AB 25 (2025), which we actively opposed.

### STEP 2: Other-Focused: Education & Connection

• Tell at least TWO other people what you have learned about *Louisiana v. Callais*, the SAVE Act, and/or ongoing challenges to election integrity in California.

### **STEP 3: Politically-Focused**

- Reach out to your legislators about the SAVE Act. Click <u>HERE</u> to access AAUW's Two-Minute Activist page, then click on "Tell the Senate: Oppose the SAVE Act".
- Reach out to your legislators to do something proactive to protect voting rights. Click <u>HERE</u> to access the Center for Common Ground web page to ask Congressional representatives and senators to champion passage of the John Lewis Voting Rights Advancement Act (HR 14), supported by AAUW.
