



2016-17 Membership Dues and Fees Schedule

Effective March 16, 2016 through June 30, 2017

California AAUW members pay a bundled payment for three organizational segments

1. AAUW National dues
2. State dues
3. Branch dues, if a branch member

Branch dues and fees are set by the individual branches, are not uniform and are in addition to AAUW National and AAUW California Dues.

Dues are typically paid in a single payment, collected by the branch or paid online by the member via the Membership Payment Program.

Branches may waive branch dues in some categories.

| Give a Grad a Gift | 1st Year Free | 1st Year Free | Varies | Give a Grad a Gift can be given to an eligible graduate up to two years after graduation. |

| National (only) Member | \$49 | N/A | N/A | Members may join AAUW online and be unaware of the opportunity to participate in a branch. Members receive AAUW Outlook. Also called Members at Large (MAL) and are listed on the member Services Database (MSD) |
| National Paid Life Member | \$980 | \$20 | Varies | The full amount of the one-time national fee amount is tax deductible. |

| AAUW California Member-at-Large | \$49 | \$20 | N/A | Members receive AAUW Outlook and the California Perspective. AAUW national members may also join as AAUW California Members-at-Large. |
| 50 Year Honorary Member | Dues waived | Dues waived | May be waived by branch | 50 Year Honorary Life members will be certified by AAUW National after documentation of their paid AAUW membership over a 50-year period. Branch Membership VPs submit form to National and inform the State Membership Director(s) when a member has been deemed eligible by National so that AAUW CA can send them a congratulatory letter and inform him/her that they no longer pay state dues. |
