AAUW California has a critical governance issue that must be addressed through an "every member" vote.

It is important that every member of AAUW California cast a vote in favor of changing our non-profit status from mutual benefit to public benefit.

**Voting period:** September 10 – October 1, 2017 **How to vote:** 

- Members with an email address will receive a link to vote online.
- Members without an email address will receive a postcard with instructions on how to vote online or via telephone.

# Vote topic:

 Approve changing AAUW California's status from a Mutual Benefit to a Public Benefit entity.

# Why vote:

We risk losing our affiliate status with AAUW National which would mean we would no longer a be recognized AAUW entity and as such would no longer be eligible to participate in any AAUW programs, such as Tech Trek.

Question Period: Now until September 9, 2107.

# **BRANCH BYLAWS AND AFFILIATES** AGREEMENTS COMPLIANCE

Every branch should now have on file with National their updated bylaws. These should reflect National's mandated updates. If your branch does not have these bylaws on file with AAUW National, you will be receiving a "non-compliance letter" from AAUW National with notice of a required deadline by which your branch must be in compliance.

Impact of not being in compliance:

- Risk having your AAUW affiliation revoked.
  - Your branch will no longer be recognized as an AAUW affiliate.
  - o Your branch will no longer be eligible to participate in AAUW programs at all levels.
  - Your branch will have no insurance coverage or recognition as an AAUW entity.

# Are your bylaw in compliance?

The AAUW California Governance Committee has received a list of those branches that do not have bylaws on file as of August 1, 2017. Governance Committee members will be reaching out to those branches in the coming weeks to assist you in rectifying the issue of noncompliance.

# We submitted our bylaws but we are still listed as non-compliant:

If you are contacted and you have submitted updated bylaws to AAUW National, you'll be asked to provide the date on which they were submitted to AAUW National as well as the way in which they were submitted (i.e. a direct e-mail to compliance@aauw.org or through the AAUW National website MSD portal).

The Public Policy Program supports AAUW's mission of advancing equity for women and girls through advocacy, education, philanthropy, and research and speaks to women's needs, aspirations, and concerns. A significant portion of both national and state dues supports researching and developing AAUW's positions on legislation impacting women and girls, and lobbying efforts. A paid legislative advocate represents AAUW California in the California Legislature. In Washington, AAUW staff and volunteers communicate with legislators.

# EQUITY FOR WOMEN IS THREATENED IN THE CURRENT PARTISAN POLITICAL CLIMATE!

The current political climate threatens progress on a number of women's issues, such as reproductive freedom, equal pay, and other economic issues. AAUW is a respected organization able to influence Public Policy! Branch leaders can play an important role by keeping branch members informed and encouraging action.

- Appoint a Branch Pubic Policy Chair to receive information and put articles in branch newsletters.
- Include at least one Public Policy program in your branch programming during the year, especially this fall leading up to the November election.

- Meet with your legislators in their district offices to inform them about AAUW's mission and legislative priorities – establishing a relationship can enhance two-way communications. Use the website's <u>Advocacy Training program</u> to prepare.

# THE PUBLIC POLICY PROGRAM GOVERNS ALL ACTIONS IN THE NAME OF AAUW.

Public Policy activities are based on our priorities.

 Public Policy Priorities at both national and state levels guide AAUW CA's actions related to public policy. These are reviewed and revised every two years.







- AAUW has a long tradition of advocating for positive societal and economic goals, both at the national and state levels. AAUW is positively regarded by legislators for its studied, well-informed positions on proposed legislation, and for its research projects.
- The Public Policy Program governs ALL ACTIONS in the name of AAUW.

### **AAUW CALIFORNIA PUBLIC POLICY PLANS FOR 2017-2018**

- Get Out the Vote (GOTV) Assisting voters and voter education should be high priorities for branches in the local elections this November. Register voters, hold educational forums, remind people to vote.
- Public Policy Priorities The priorities were renewed this past spring. The current twoyear priorities can be found on the AAUW California website.
- Legislative Advocacy Encourage members to sign up for Action Alerts on the national website, and they will also be enrolled in state Action Alerts. Follow the progress of California bills on the state website. Communicate AAUW positions on bills with those elected to represent you.
- Title IX Raise awareness in your community about the status of compliance in local school districts. Title IX covers much more than just athletics.
- Communicate about Public Policy Share information to educate members about important issues. In addition to branch newsletters use social media, including Facebook and Twitter, to communicate with members and non-members. AAUW California's Facebook presence is a tool to keep members current on our tracked bills and relevant policies.

Resolutions are important tools for focusing, developing, and giving direction to AAUW program and policy, and are frequently the outgrowth of study/action by the membership. Resolutions establish a framework within which some kind of action may be taken.

# Who can propose a resolution?

Any member or branch

# How is a resolution adopted?

By a majority vote of the membership

### Due Date:

November 15, 2017

### Submit to:

Parliamentarian – use the form on next page

Resolutions may be proposed by any of the AAUW officers, task forces and committees, a branch, or any member. Such resolutions must be compatible with established AAUW and AAUW California policies, programs, and principles.

In order for resolutions to be included in the normal voting process, they must be submitted, along with the financial impact. Receipt of a proposed resolution will trigger the establishment of a state Resolutions Task Force, which may approve, reject or refer back to the maker with recommendations.

The purpose and scope of resolutions and detailed procedures for formatting resolutions are detailed in **Policy 111-Resolutions** of the AAUW California Policies and Procedures, which can be found on the "AAUW CA Business" section of the state website.

The resolutions chair will notify each branch and members of the Board of Directors of the proposed resolutions at least 30 days prior to commencement of voting. Such notice will be in the pre-election mailing to branches and officers.

The format for resolutions follows and is also be posted on the AAUW California website. Mail or email copies of your proposed resolutions by the posted deadline to the AAUW California office and to the parliamentarian.
