

# AAUW Dues, Fees, and Tax Deductibility

Effective March 16, 2019

## AAUW California members pay a bundled payment for three organizational segments

1. AAUW National dues
2. State dues
3. Branch dues, if a branch member, are set by the individual branches, are not uniform, and are in addition to AAUW National and AAUW California Dues.

Dues are typically paid in a single payment, collected by the branch or paid online by the member via the Membership Payment Program.

<b>National Membership*</b> Individuals holding an associate or higher degree from a higher education institution accredited by a regional accrediting agency recognized by the U.S. Department of Education <b>AAUW California Members-at-Large</b> pay national and state dues only. <b>Branch members</b> pay national and state dues in addition to the applicable dues for each local branch of which they are a member.	\$59	\$20 (waived for past state presidents)	Varies
<b>Paid Life Membership*</b> Individuals who qualify for national membership may pay 20 times the national rate one time and become exempt from further national dues.	\$1,180 one time payment	\$20 per year	Varies
<b>Honorary Life Membership</b> Individuals who qualify for national membership and have been members for 50 years can apply for honorary life membership and become exempt from further national and state dues.	\$0	\$0	May be waived by branch
College/University (C/U) Memberships and Students	National Dues	State Dues	Branch Dues
<b>C/U Membership*</b> Any accredited higher education institution is eligible to become a C/U member and can appoint one or two eligible representatives to receive free national membership. Local branch and state membership dues are an additional cost.	\$175	\$0	N/A
<b>Memberships for Students of Non-AAUW C/U Members*</b> Undergraduates or degree-seeking graduates enrolled in full-time or part-time programs may join and renew at this rate through graduation.	\$18.81	\$10	Varies
<b>Memberships for Students of AAUW C/U Members</b> Undergraduates or degree-seeking graduates enrolled in full-time or part-time programs may join and renew at no cost with automatic renewal through graduation.	\$0	\$0	Varies

<b>Shape the Future*</b> For new members who join AAUW at a public event.	\$29.50	\$20	Varies

### \*Tax Deductibility

**AAUW national membership** dues are \$59, of which \$56 is tax deductible as a charitable contribution.

**AAUW national paid life membership** dues are \$1,180 and is fully tax deductible.

**C/U membership** dues are \$175 and is fully tax deductible.

**Student membership** dues are \$18.81, of which \$16.81 is tax deductible.

**Shape the Future membership** dues are \$29.50 of which \$26.50 is tax deductible.
