#### A RAINBOW OF FACES

# **State Membership Dues**

It is the end of the calendar year, and as your members file their personal tax returns, remember that AAUW California is a 501(c)(4) entity, and state dues of \$20 are NOT taxdeductible.

There has been some confusion about who does and does not pay state dues. Here is a reminder of the rules:

1. 50-Year Honorary Members are exempt from paying state dues. (Note, paid life members must pay state dues).

What I need to know: There will be a Finance workshop at the 2020 convention to address common questions.

What I need to do: Use this list of rules to answer members' questions about the deductibility of state dues.

Should I include this in my branch newsletter? No, this information is for the branch leaders only.

- 2. Younger Women's Task Force members' state dues are 75% of state member dues.
- 3. New members who receive AAUW membership through national AAUW's "Give a Grad a Gift" program, are exempt from state dues for their first year of membership.
- 4. State dues are waived for past state presidents.
- 5. State dues are waived for college/university partner representatives.
- 6. State dues for graduate students are half the state dues.
- 7. Student affiliates pay one-half the annual AAUW California fee for affiliation with AAUW California.
- 8. State student affiliate fees are waived for e-student affiliates.

#### **ENGAGING INTROVERTS IN LEADERSHIP ROLES**

The Leadership Development workshop held in Sacramento on November 2nd included recognizing the value of introverts in leadership roles. A key characteristic of introverts is the ability to listen. One of the workshop activities was partnering with another participant in order to identify that person's strengths and reporting those strengths to the entire group. The process of engaging one other person makes it possible for introverts to be included. According to Susan Cain in her book Quiet, we greatly underestimate the value of introverts who may be innovative but not necessarily self-promoting. Part of leadership development involves the recognition of talents and the power that comes by using them. In our branches, we can be mindful of some of the quiet members who can contribute their talents.

#### **END OF YEAR DONATIONS AND TAX DEDUCTIONS**

December 31 is quickly approaching --- it's time to get those end-of-the-year 2019 tax-deductible donations submitted to the Special Projects Fund for processing before the close of the year. This includes all donations for Tech Trek, Speech Trek, and branch projects & scholarship programs using SPF as their non-profit fiduciary agent.

Don't miss the opportunity to receive a tax deduction on your donation for 2019. Mail early!

Donors will receive their acknowledgment letters from SPF no later than January 31, 2020, which is the federal deadline for acknowledgment. SPF acknowledges all donations of \$250 and above, with branches directly thanking donors for those donations below \$250.

#### **TECH TREK: 2020 BRANCH PACKETS DELIVERED**

Tech Trek Branch coordinators and leaders received the 2020 Branch Packet, which is comprised of three zipped files: Documents, Logos & Letterhead, and Brochures. Conduct a thorough leadership review of the new documents before training team members who will meet with schools or work with students. Ensure that your branch Tech Trek team is trained and meets compliance requirements before the 2020 season's activities reach schools and students.

- Branch Packets Delivered: Download the packet from the AAUW California website <u>HERE</u>. The packet contains three files to download and unzip. You will be required to input the password: aauwca
- Branch Packet Review & Training: Branch coordinators and key leaders should meet to carefully review and discuss all Branch Packet materials.
- Read Branch Packet Overview: Take the time to review
  the folders, schedule and conduct training with Tech Trek
  project team members before schools and/or students are
  contacted. Ensure all required forms are signed and
  submitted on time.
- Branch Packet Form Compliance: Branch and camp leaders are not allowed to change or modify the 2020 materials without California Co-Coordinators' review and change authorization. If there are concerns or questions about a form or how to handle it, adhere to risk management best practices and contact the California Co-Coordinators for support.
- Coming Soon! A 2020 Code of Conduct Form will be distributed in early December. Old or modified forms are not acceptable. Establish that all trained team members have signed the correct 2020 form and return it by 12/31/2019 (or before contact with schools/students begins).
- Help Reduce Your SPF Issues: Since many California branches use the same acronym, please don't use one (or abbreviate your branch name) in the SPF form's branch section. Ensure that your branch name is clearly stated to facilitate efficient SPF processing.
- Branch Packet Questions? Don't assume answers contact the AAUW California Tech Trek Co-Coordinators to ensure clarity!

What I need to know: 2020 Tech Trek Branch Packets can be downloaded from the AAUW California website.

What I need to do: Share this information with your branch Tech Trek coordinator and assure that all key people have read the packet thoroughly.
