# Overview of Legislative Agenda 2023-24

34 Bills selected

2 Co-sponsored + 1 other A bill; 3 B bills; 24 C bills

8 “Economic Security” bills

11 “Public Education” bills

21 “Social Justice” bills

- 8 “reproductive justice”
- 5 “healthcare”
- 5 “freedom from violence” including sex exploitation, domestic violence, stalking
- 1 “gender-identity protection”
- 2 “voting rights”



## AB 1394 (Wicks)

## What does it do?

- Allows victims of child sex exploitation to sue large social media platforms
  - If they can prove the platform knowingly, recklessly or negligently facilitated, aided or abetted child exploitation
  - And/or if the platform refuses their request to render invisible any images or videos posted of them on the platform.



# AB 1394 cont'd

## How is it proven?

- Does the platform design facilitate the use of code words for sexual predators to describe the type of child and the type of sexual activity?

## How is it enforced?

- Victim may be awarded damages of \$1 million to \$5 million for each act of exploitation.



# AB 1394 cont'd

## Why is it needed?

- 38% of tweens and 84% of teens use social media.
- 1/4 of 9-17 year olds report having had a sexually explicit interaction online with someone they believed to be an adult.
- Since 2000, traffickers have recruited 55% of sex trafficking victims online, usually through social media platforms.
- Social media platforms are aware that sexual abuse, exploitation and trafficking of children are originating on their platforms, yet they continue to rely on inadequate self-policing which is facilitating the dramatic increase in online sexual exploitation.

This bill will provide an incentive for social media platforms to better police their designs to reduce the ease with which predators can use them to attract potential teen victims.

# SB 287 (Skinner)

## Social Media Features That Harm Children

What does it do?

- Would prohibit a social media platform from using a design, algorithm, or feature that the platform knows, or which by the exercise of reasonable care should have known, causes child users to:
  - Purchase fentanyl
  - Inflict harm on themselves or others
  - Develop an eating disorder or engage in dangerous dieting
  - Purposely take their own lives and/or experience addiction to the social media platform
- Provides a penalty of up to \$250,000 for each violation



# SB 287 (cont'd)

- A social media platform is not in violation of the bill if it instituted and maintained a program of at least quarterly audits of its designs, algorithms, and features to identify those that have the potential to cause or contribute to violations of this provision.
- And the social media platform corrected, within 30 days of the completion of the audit, any design, algorithm, or feature discovered by the audit to present more than a de minimis risk of violating the provision described above.

(Note: this is a package bill with AB 1394)

# AB 549 (Wilson) - Gender Discrimination

## What does it do?

- Requires all state agencies to conduct an evaluation of all their departments to ensure the state does not discriminate against women
- Enacted through the implementation of policies and programs, including allocation of funding and delivery of services
- Requires agencies to report their findings to the California Commission on the Status of Women by January 2024 and January of every two years thereafter, with recommendations for necessary changes





# AB 549 (cont'd)

## Why is it needed?

The Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW) is an international “Bill of Rights” for women. It is the first and only international instrument that comprehensively addresses women’s rights within political, cultural, economic, social, and family life.

There is a continued need for the state of California to protect the human rights of women and girls by addressing discrimination, including violence, against them and to implement the principles of the CEDAW. Adherence to the principles of the CEDAW on the state level will especially promote equal access to and equity in health care, employment, economic development, and educational opportunities for women and girls and will also address the continuing and critical problems of violence against women and girls.

The state should implement the principles underlying the CEDAW by addressing discrimination against women and girls in areas including, but not limited to, economic development, education, employment practices, violence against women and girls, and health care products and services.

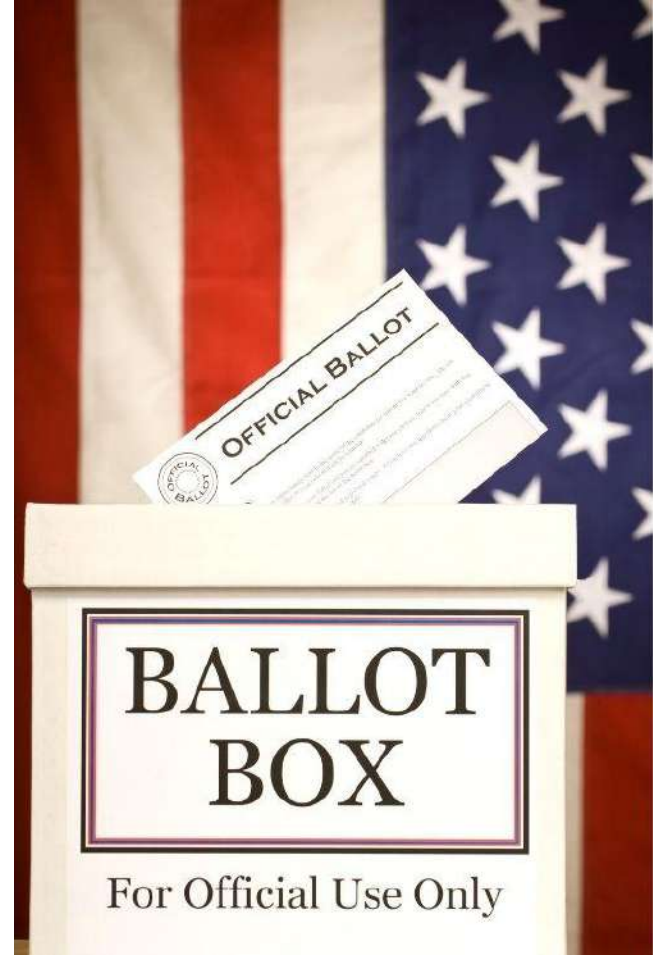

# Program Overview

- **Our Goal:** Gov Trek is a virtual statewide program designed to engage young women across California who are high school juniors and seniors with the goal of elevating a new generation to pursue careers in public service and elected office.
- **Learning Outcomes:** Participants have engaged in learning about career paths and career journeys from guest speakers and engaged in a team competition to create a realistic campaign simulation.
- **Skills Gained:** Participants have met peers from across California, sharpened their public speaking skills, written speeches, designed political fliers and digital ads, conducted audience analysis for voter outreach, making their college applications stand out.

# Financial Position

## Checking Account: \$ 135,971

- Last year this time: \$ 129,467 (fairly comparable)

## Investments as of March 31, 2023 (total): \$ 416,419

- Operating Reserve: \$ 244,112
- Projects Reserve: \$ 157,145
- General Reserve: \$ 15,162

## Investments on June 30, 2022 (total): \$ 395,053

- 5.4 % increase on investments since July 1
- Over \$ 20,000 decline since a year ago (March 31, 2022)



# Financial Activity

**Membership Dues Income: \$ 154,780** (this time last year \$ 163,720)

- Budgeted: \$ 160,000 (last year's budget \$ 170,000)
- Shortfall: - **3.26 %** (comparable to last year)

**Expenses to Date: \$ 116,393**

- Office manager, storage, supplies: **\$ 30,480** (26%)
- Public Policy: **\$ 48,441** (42%)
- Travel for board meetings etc: **\$ 11,401** (10%)
- Software and website: **\$ 8,049** (7%)
- Finance, CPA, tax filing: **\$ 7,600** (6%)
- BOR upgrade (one time, from reserves): **\$ 9,382** (8%)
- Printing, mailing, elections, misc: **\$ 1,040** (1%)



**Adequate funds remaining for rest of the year + carryover**

# Comments on Finance

- State finances in good shape, no increase in state dues
- Expect to end the year in the black
- Started in person travel for some board meetings/retreat
  - Using hybrid approach of 2 meetings in-person, 3 on Zoom
  - Committee Day, annual event continue on Zoom
- Membership income declines each year, expenses go up
  - Cost cutting approaches by going virtual have helped with budget
  - We're okay this year, but it is a concern
- Reserves are healthy
- Investments doing better this year than last, but have yet to make up the huge prior loss - oversight provided by Investment Committee
- Annual financials for this year will be available on the website in the fall



# Finance - Upcoming Activities

Pilot program to use QuickBooks Online for Tech Trek camp accounting

- Will make accounting easier, with better reporting and oversight
- Required significant development work
- Training material created, and training is in progress
- Will be used by some camps this year, and all camps next year
- Tremendous effort by team led by Kathy Ford

## PUBLIC POLICY PRIORITIES

The AAUW California Public Policy Program establishes policy directives that will guide our members, inform our legislative priorities, serve our mission to advance equity for women and girls through advocacy, and are consistent with our values of achieving fair and equitable opportunities for our diverse society. Toward that end, AAUW California advocates policies that promote, enhance and ensure:

### Economic Security for All Women, including:

- Equity in the workplace
- Enforcement of workplace anti-discrimination statutes
- Security in retirement
- Access to job training for career development
- Work-life balance, including access to quality affordable childcare and paid sick and caregiving leave

### Social and Racial Justice for All Members of Society, including:

- Self-determination in reproductive health
- Equal access to quality affordable health care, housing and a healthy environment
- Freedom from violence in all its forms and wherever it occurs, including violence against historically marginalized groups, and support for policies that reduce or prevent gun violence.
- Guarantee of civil and constitutional rights for all, including all forms of gender identity and expression, and all family structures
- Protection and expansion of voting rights
- Support for United Nations sustainable development goals which address human rights and women's and girls' concerns

### Equal Access to Quality Public Education for All Students, including:

- Vigorous enforcement of Title IX
- Adequate and equitable funding at all educational levels, including pre-school and post-secondary
- Removal of barriers for girls to access instruction in STEM fields
- Civics instruction in all CA high schools
- Access to diverse staff and curriculum that represents historically accurate information
- Funding adequate to support a strong infrastructure, and equitable access to resources, including technology
- Opposition to the use of public funds for nonpublic and charter schools that do not meet public school civil rights and accountability standards

### Increased Representation of Women in Leadership Roles, including:

- Proportional appointment to publicly held corporate boards
- Access to leadership skills training
- Access to programs that promote participation in public service careers

## Basis for Public Policy Priorities

The AAUW California Public Policy program supports AAUW's mission to advance equity for women and girls through advocacy, education and research.

AAUW California's Public Policy Priorities are consistent with national AAUW Public Policy Principles and are updated every two years with input from membership.

Legislative activism has a long history in AAUW. Members first lobbied for women's suffrage in 1892 and have continued to be responsive to the critical issues of the times.

- This program is specifically for first-generation Latino students to feel that they have support in being successful in the highest levels of academic success and leadership in their schools.

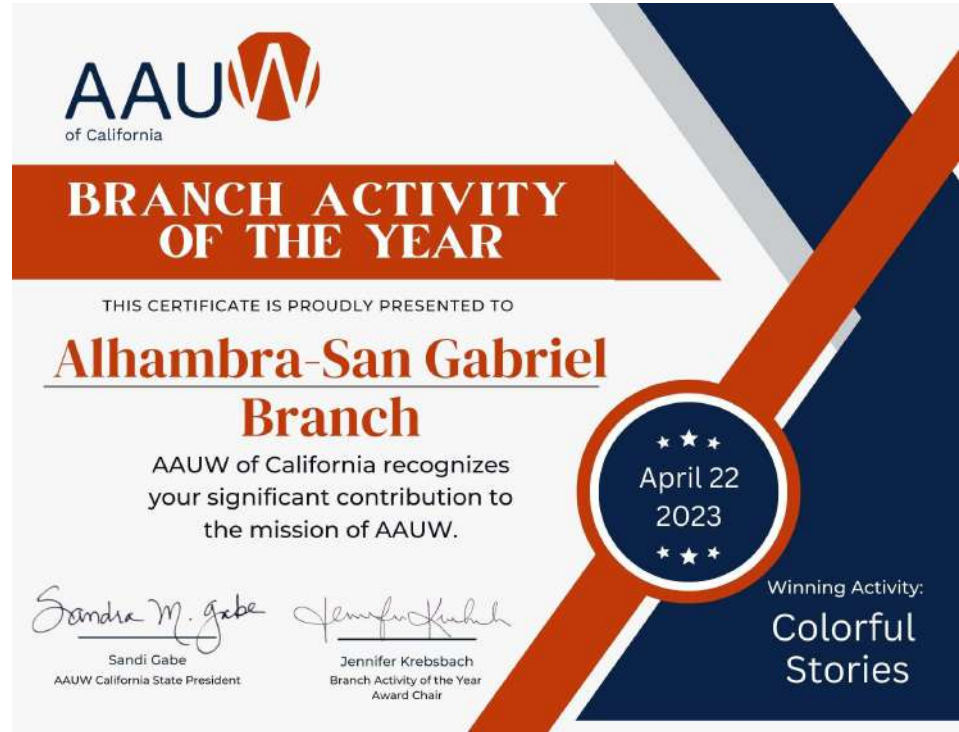

# Colorful Stories

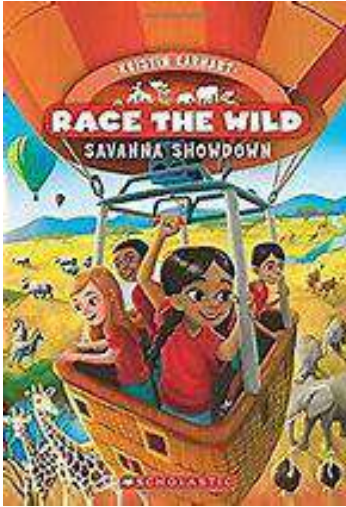
