# SCHOOL BOARD PROJECT

Check Out SBP's Updated Resources!

There is a movement across the country as well as here in California to install school board members who want to ban books, censor curricula, and establish policies that are harmful to LGBTQ+ students. **The School Board Project (SBP) subcommittee has been formed to assess the extent of the issue in California, AAUW California membership's concern over the issue, and members' willingness to take action.** SBP also provides the Public Policy Committee and state board with recommended courses of action.

For the many members who have already expressed concern over these issues (and an interest in taking action), SBP members have created a helpful toolkit for protecting your School Board from members who support book-banning, curriculum censorship, and anti-LGBTQ+ policies. **Check it out by clicking [HERE](#).**

Contact Governor Newsom to encourage him to sign AB1394 (Wicks) before 10/14/23.

**In September, we had the opportunity to roll out our first official action alert** as we worked to get Governor Newsom to sign one of our priority bills: AB 1394. AB 1394 prohibits social media companies from designing infrastructure that knowingly facilitates, aids, or abets commercial sexual exploitation. This helps protect our children from sex abuse and sex trafficking. You can read more about the bill [HERE](#).

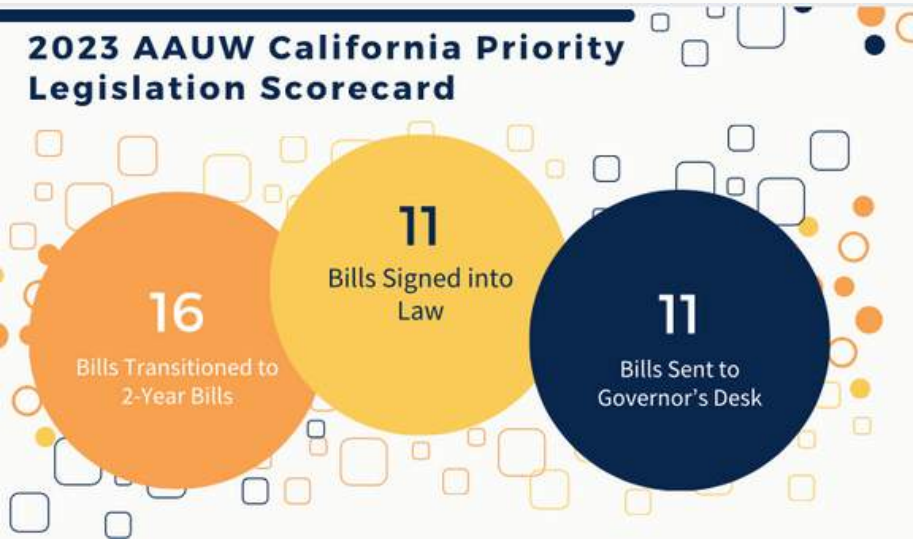
# 2023 California Legislative Session Round-Up: AAUW California's Priority Legislation

September 14, 2023 was a tense day in Sacramento: the last day for each House to pass bills that could be sent on to the governor. After at least nine months of writing, researching, amending, and lobbying, the legislative session drew to a close. So how did AAUW California's priority legislation fare?

While, at the time of writing, AAUW California still has some priority legislation sitting on the governor's desk (he has until October 14, 2023 to sign), we are happy to report that our priority bills did pretty well in this cycle!

in the session at the request of the SBP Subcommittee, as it deals with preserving historically accurate and representative curricula for public schools in California. We are excited to report that three of our B-level bills have been signed into law: AB 524, AB 1071, and AB 1078. SB 36 has been transformed into a 2-year bill.

We had thirty-one C-level bills this year. Eight of our C-level bills were signed into law. Ten are awaiting the governor's signature, and thirteen are now 2-year bills. Our three A-level bills this year were AB 1394, AB 549, and SB680. AAUW California was also a co-sponsor on AB1394. While none of our A-level bills have yet been signed into law, AB 1394 is currently sitting on the Governor's desk awaiting a signature. AB 549 and SB 680 have both been transformed into 2-year bills.

Our four B-level bills this year were AB 524, AB 1071, AB 1078, and SB 36. AAUW California added AB 1078 later

## A-Level Priority Bills

**AB 1394. Sent to Governor's Desk.** Authored by Assemblymember Buffy Wicks, and co-sponsored by AAUW California, this bill seeks to help child sex abuse survivors remove their images from social media platforms, holding big tech accountable for design features that knowingly, recklessly or negligently facilitate, aided or abet child exploitation.

**AB 549. 2-Year Bill.** Authored by Assemblymember Lori Wilson. This bill would require all state agencies, in consultation with the Commission on the Status of Women and Girls, to conduct an evaluation of their own departments to ensure that the state does not discriminate against women through the allocation of funding and the delivery of services.

**SB 680. 2-Year Bill.** Originally introduced as SB287, and authored by Senator Nancy Skinner, this bill prohibits a social media platform from using a design, algorithm, or feature that the platform knows, or by the exercise of reasonable care should have known, causes child users to experience addiction to the social media platform. This bill would subject a social media platform that knowingly and willfully violates these provisions to a civil penalty.

## B-Level Priority Bills

**AB 524. Signed into Law!** Authored by Assemblymember Buffy Wicks, this bill would prohibit discrimination against employees based on their status as a family caregiver, making it unlawful for employers to refuse to hire, fire, demote, or take other adverse employment action against workers because of their family responsibilities.

**AB 1071. Signed into Law!** Authored by Assemblymember Joshua Hoover, this bill would authorize and encourage school districts, county offices of education, and charter schools to provide teen dating violence prevention (TDV) education to all pupils in grades 7-12, at least once in middle school and once in high school. It also requires the District to make TDV resources available on its website.

**AB 1078. Signed into Law!** Authored by Assemblymember Dr. Corey Jackson, this bill expands the diversity of the social science curriculum, requiring instruction in social sciences to include a study of the role and contributions of people of all genders, Latino Americans, LGBTQ+ Americans, and other ethnic cultural, religious and socioeconomic status groups. If the school district has not provided sufficient textbooks or instructional materials, their local control funding formula allocation will be reduced.

**SB 36. 2-Year Bill.** Authored by Senator Nancy Skinner, this bill provides protections and support for any person fleeing prosecution, conviction, or sentence from another state for seeking abortion, contraception, reproductive care, or seeking gender-affirming care in California. It also provides protections for any person assisting the person seeking that care.
